

NOTICE TO BIDDERS / INVITATION TO BID

1. Notice is hereby given that the governing board ("Board") of the Fairfield-Suisun Unified School District ("District") will receive sealed bids for the following project:

BID #20F-129 Suisun Elementary Admin Modernization & Restroom Building

2. To bid on this Project, the Bidder is required to have been prequalified by the District. In addition, if components of the Project will be performed by electrical, mechanical, or plumbing subcontractors performing under the following license classification(s), then each of those subcontractors that intend to bid as a first-tier subcontractor to a general contractor (prime contractor) are required to have been prequalified by the District: C-4, C-7, C-10, C-16, C-20, C-34, C-36, C-38, C-42, C-43, and/or C-46. All prequalification questionnaires will be received until 5:00 p.m., February 25, 2020, at the District Office website: <https://www.fsusd.org/Page/16414>
3. Sealed Bids will be received until 9:00 a.m., March 10, 2020 at the office of the Facilities & Construction Department, located at 2490 Hilborn Road, Fairfield, California, after which time the bids will be opened and publicly read aloud, in conference room #102 at 2490 Hilborn Road, Fairfield, CA 94533. Any claim by a bidder of error in its bid must be made in compliance with section 5100 et seq. of the Public Contract Code. Any bid that is submitted after this time shall be non-responsive and returned to the bidder.
4. The Project consists of:

Modernize Administration lobby and reception with new circulation path and reception desk. Modify electrical, mechanical, fire alarm, and data systems. Construct new slab-on-grade toilet building. Perform asphalt paving, concrete, grading, drainage, fencing and landscaping upgrades in support of play area reconfigurations. Build new shade structures and resilient-surfaced play equipment areas, install owner-furnished new play equipment.
5. All bids shall be on the form provided by the District. Each bid must conform and be responsive to all pertinent Contract Documents, including, but not limited to, the Instructions to Bidders.
6. To bid on this Project, the Bidder is required to possess one or more of the following State of California Contractor Licenses:

A (General Engineering) or B (General Building)

The Bidder's license(s) must be active and in good standing at the time of the bid opening and must remain so throughout the term of the Contract.

7. As security for its Bid, each bidder shall provide with its Bid form
 - a bid bond issued by an admitted surety insurer on the form provided by the District,
 - cash, or
 - a cashier's check or a certified check, drawn to the order of the Fairfield-Suisun Unified School District,in the amount of ten percent (10%) of the total bid price. This bid security shall be a guarantee that the Bidder shall, within seven (7) calendar days after the date of the Notice of Award, enter into a contract with the District for the performance of the services as stipulated in the bid.
8. The successful Bidder shall be required to furnish a 100% Performance Bond and a 100% Payment Bond if it is awarded the contract for the Project.

9. The successful Bidder may substitute securities for any monies withheld by the District to ensure performance under the Contract, in accordance with the provisions of section 22300 of the Public Contract Code.
10. The successful Bidder and its subcontractors shall pay all workers on the Project not less than the general prevailing rate of per diem wages and the general prevailing rate for holiday and overtime work as determined by the Director of the Department of Industrial Relations, State of California, for the type of work performed and the locality in which the work is to be performed within the boundaries of the District, pursuant to sections 1770 et seq. of the California Labor Code. Prevailing wage rates are available from the District or on the Internet at: <<http://www.dir.ca.gov>>. Bidders and Bidders' subcontractors shall comply with the registration and qualification requirements pursuant to sections 1725.5 and 1771.1 of the California Labor Code.
11. A mandatory pre-bid conference and site visit will be held on **February 18, 2020 at 12:00 p.m.** at Suisun Elementary, 725 Golden Eye Way, Fairfield, CA, for the purpose of acquainting bidders with the bid documents and the work site. **Please meet in front of the school office.**

13. The District's Board reserves the right to reject any and all bids and/or waive any irregularity in any bid received. If the District awards the Contract, the security of unsuccessful bidder(s) shall be returned within sixty (60) days from the time the award is made. Unless otherwise required by law, no bidder may withdraw its bid for ninety (90) days after the date of the bid opening.
14. The District shall determine the low bid based upon the base bid plus alternate. The District reserves the right to award at its discretion the base bid, with or without any alternate, or to not award at all.
